Legislative Update



Councilmember McDuffie continues to champion legislation to help working families, ensure transparency in government, and work for equal justice and opportunity in the District. Here are updates on some of the latest bills:

Rail Safety and Security Amendment Act - In the wake of the May 1, 2016
train derailment and spill at the railroad tracks that cross Rhode Island Avenue
NE, this bill would create a District-level oversight body charged with working
with the Federal Railroad Administration to ensure that the trans that travel

- through the District are safe. By creating a local oversight body, trains that travel the District will be subject to more inspections and increased safety-related supervision. This bill passed a second vote at the Council and now goes to the Mayor.
- Limiting the use of Credit History in Employment This bill prohibits employers from considering an applicant or current employee's credit history. Nearly half of employers check an employee's credit history when hiring for some or all positions, and its use often determines whether an applicant is hired. However, credit history is actually not a very good indicator of how an employee might perform on the job. Furthermore, poor credit history more frequently affects low-income individuals, women, and people of color, which in turn affects the employability of applicants from those backgrounds. This bill passed a second vote at the Council and now goes to the Mayor.
- 'Ban the Box' on Housing This bill limits what aspects of a person's criminal record housing providers can consider when evaluating an applicant for tenancy. Crimes committed more than seven years ago may not be considered and neither can arrests that did not result in a conviction. This legislation also prohibits housing providers from asking about any criminal history until after a conditional offer is made. There are 45 crimes listed in the bill that are allowed to be considered; these crimes include murder in the first degree, arson, burglary, sexual assault, and aggravated assault. This legislation does not apply to rental buildings with four units or fewer, one of which is owner-occupied. This bill passed a second vote at the Council and now goes to the Mayor.
- Universal Paid Family Leave This legislation got a lot of news coverage recently. Councilmember McDuffie voted in the majority on this bill to support working families in the District of Columbia. This bill provides eight weeks of paid family leave for parents to bond with newborn or adopted children, six weeks to care for an ailing parent or family member, and up to two weeks leave for a personal serious health condition. The bill would increase businesses taxes by .62% and use that money to compensate employees on leave. Those on paid leave would receive up to 90% of their salary, with the maximum benefit being \$1,000 per week. This bill passed a second vote at the Council and now goes to the Mayor.






DC Health Link's open enrollment season began on November 1st. Residents have until January 31, 2017 to enroll in quality affordable health insurance for themselves and their families. Residents can apply for Medicaid throughout the year. There is FREE expert enrollment support and as well as financial help with monthly premium.

Please note the outcome of the 2016 presidential election doesn't impact your ability to enroll residents in health insurance for 2017. DC Health Link has 20 private health insurance options to choose from for residents and their families from CareFirst and Kaiser Permanente. Small businesses have 151 health plan options from Aetna, CareFirst, Kaiser and United. Small businesses can sign up throughout the year.
